**AMENDED ORDER ON APPLICATION FOR EXCEPTION  
TO SINGLE SALE MORATORIUM AND ON VOLUNTARY AGREEMENT**

On February 17, 2010, by Order No. 2010-031, the Alcoholic Beverage Control Board (Board) granted the Application filed by Friendly David's Market, Inc., t/a Friendly Food Market (Applicant), for Exception to Single Sales Restriction. As a part of its Order, the Board ordered that its approval of the Application be limited to one year from the date of the Order.

The Board now seeks to amend Order No. 2010-031 to make clear that its official records reflect that the Board's approval of the Application is perpetual and not limited to one year. All other terms and conditions adopted by Order No. 2010-031 shall remain in full force and effect.
