- 6. <u>Proposed Southwest BID</u>. Mr. Steve Moore presented the case for establishing at Southwest Business Improvement District 9SWBID). Following discussion, Commissioners voted 5-0 to support the creation of the SWBID and 5-0 that the ANC Chairman be authorized to speak before the City Council in support of the SWBID.
- 7. <u>Virginia Avenue Tunnel</u>. The Commission voted 5-0 to allow time for a revision to the draft of the Garber letter responding to the Draft Environmental Impact Statement regarding CSX Corporation's proposed reconstruction of the Tunnel, which report some potentially affected residents believe to be seriously deficient. By vote of 5-0, Commissioners agree that Commissioner Hopkins would undertake to provide a revised draft of the letter by 5:00 p.m. Friday, September 20 for consideration at a special public meeting to be held at 10:00 a.m. Sunday, September 22 at the ANC offices.
- 8. <u>ZC#10-31</u>, DC Ballpark, Modification of Capitol Overlay Application, South Capitol & N Streets SE, requesting four loading berths versus three. Approved 5-0.
- 9. <u>BZA #18619</u>, Square 737 LLC, 800 New Jersey Ave SE, variance for parking location. Approved 5-0.
- 10. <u>PS #85189</u>, Square 737 LLC, 800 New Jersey Ave SE, curb cuts and vaults. Consideration by the Commission was pushed to the October meeting.
- 11. <u>PS #83647</u>, Vulcan Materials Company, 2 S Street SW, parking on public space. Approved 5-0 with the stipulation that the parking plan would provide:

- a. Provide for ample pedestrian access
- b. Provide for environmental remediation
- c. Be extant for a maximum of two years; and
- d. That reserved spaces would not be made available for rented by the company during games or other events at National Stadium.
