Capt Haskis - Down on ADW, up on robberies (9 in last month opposed to 4). Half already closed. Unarmed carjacking, robbery on tingey, robbery snatch by library, 909 m st se, robbery 701 g st sw, 399 m st sw force and violence followed to metro (mpd helped by private security guard), juvenile carjacking, adw hammer, increase robbery patrols in morning and evening shift, down on motor vehicle thefts

Overall, things have been relatively stable. Continuing trends of property crimes, especially SE. Car hopins, usually deliver drivers would hop off and people would hop into vehicles.
